Anonos achieved the landmark certification following evaluation on its compliance with legal and technical requirements for pseudonymizing data under the EU General Data Protection Regulation (GDPR).

ABOUT ANONOS

Founded in 2012, Anonos is a global data enablement/privacy technology solutions provider. Its services allow companies to comply with personal data protection regulations, for example the European Union's General Data Protection Regulation (GDPR).

Anonos's flagship technology product – BigPrivacy® – enables the transformation of stored personal data into pseudonymized and/or anonymized datasets, and the de-pseudonymization of selected data for compliant processing. A simplified version – SaveYourData – enables rapid pseudonymization and/or anonymisation to transform data so that it remains legal to possess by leveraging GDPR compliant pseudonymization.

To prove compliance with GDPR, Anonos required a state-ofthe-art certification scheme capable of managing the complex requirements introduced under GDPR.

CERTIFICATION PROCESS

A team of auditors with legal and technical expertise undertook an assessment of the product against the EuroPrivacy certification scheme, in conformity with ISO/IEC 17065. The auditors systematically checked the compliance of the solution against each of the requirements in GDPR. The assessment accounted for the complete life cycle of the product, from deployment to deletion.

The EuroPrivacy audit team then delivered a written report with a gap analysis identifying areas that required improvement. Anonos quickly addressed these and a second assessment was performed. This delivered a successful outcome and, following validation, the certificate was published on the EuroPrivacy public registry.

Certification remains in place for a period of three years and is subject to controls by the Certification Body.

Co-funded by the European Commission and the Swiss Government through the European research programme and managed through the European Center for Certification and Privacy (ECCP), EuroPrivacy is a highly reliable and robust certification scheme for data protection. It encompasses:

- European General Data Protection Regulation (GDPR)
- Information Management Systems
- Products and Services
- Emerging technologies, e.g. Internet of Things (IoT), big data and smart cities
- Relevant ISO standards

WHAT IS GDPR?

GDPR has a global impact on personal data processing and retention by businesses. It requires businesses active in EU markets, whether they are based in the EU or not, to comply with its requirements in relation to the processing of personal data. The consequences of non-compliance can be fines up to 4% of their worldwide turnover, or €20 million (whichever is higher). Consequently, GDPR compliance has become a critical requirement and a key competitive advantage as well as a vital source of trust and reputation for companies operating in European markets.

Compliance with GDPR requires technical and organization safeguards that create functional separation in datasets. Pseudonymization represents a unique means for supporting lawful possession and processing of data as it enforces the required functional separation.
